3. Two copies of 2' x 2''' recent photographs

### **FOR ATTENDING MEETING/SEMINAR/ AND STUDY TOURS FOR ORDINARY PASSPORT HOLDERS:**

1. Invitation from the Philippines addressed to the Philippine Embassy and to the applicant
2. Letter from the Employer
3. Bank Statement of visa applicant
4. Proof of Financial capability e.g. assets/ownership, proof of tax payment
5. Passport valid for not less than six (6) months after sojourn in the Philippines
6. Roundtrip airline ticket/booking
7. Two copies of 2'' x 2'' recent photographs
8. Visa fee of Tk2,800.00

### **FOR BUSINESS PURPOSES:**

1. Invitation letter from the Philippines addressed to the Embassy
2. Company letter indicating purpose of travel to the Philippines
3. Registration of Business of the applicant and the sponsor
4. Bank Statement of visa applicant
5. Proof of financial capability e.g. assets/ownership, proof of tax payment
6. Passport valid for not less than six (6) months after sojourn in the Philippines
7. Roundtrip airline ticket/booking
8. Two copies of 2'' x 2'' recent photograph
9. Visa fee of Tk2,800.00

### **FOR TOURISM:**

1. Proof of Financial capability e.g. assets/ownership, proof of tax payment or letter/proof of financial support by the sponsor
2. Bank statement of visa applicant or letter/proof of financial support by the sponsor
3. Roundtrip air ticket
4. Passport valid for not less than six (6) months after sojourn in the Philippines
5. Two copies of 2'' x 2'' recent photographs
6. Visa fee of Tk2,800.00

### **FOR SEAMAN:**

1. Letter from the Manning Agency addressed to the Embassy
2. Photocopy of Seaman's Book
3. Passport valid for not less than six (6) months after sojourn in the Philippines
4. Two copies of 2'' x 2'' recent photographs
5. Visa fee of Tk1,400.00
